### Jeff Hufford District 2 Board Nominee

#### 1. Please tell Agralite Members a little bit about yourself.

I have lived my entire life in the Morris area, except during college. I farm with my son, brother, and nephew raising row crops, small grain, and alfalfa. We also feed cattle and have a cow/calf operation. I'm active in several organizations. I enjoy attending my grandsons' activities, as well as hunting, fishing, and traveling. I have several grills/smokers and use them often!

### 2. Why do you want to be a Director?

I've been a director at Agralite for 12 years and enjoy working with the rest of the board, staff, and employees. We are fortunate as a cooperative to have a great group of people like them in their positions. I feel that my experience on the Agralite board, as well as the East River Electric Cooperative board, gives me insight and understanding that can benefit the boardroom and the cooperative.

### 3. What aspects of the director's job do you consider the most crucial?

Working with staff to help provide member-owners with reasonably priced, reliable power in a safe way. It's important as a director to be educated as much as possible about the cooperative power model and to learn as much as we can about the needs of our membership.

#### 4. What work experience or other board experience do you have that will help you be an effective Director?

### 5. What challenges do you see for Agralite Electric Cooperative in the future and how does the cooperative meet these challenges?

Change. It comes quickly. There is a big need for new generation and lines as there is new demand almost constantly coming online. Renewables will be a large part of that generation. They will need to be incorporated with our baseline generation of hydro, nuclear, and fossil fuel in a safe, reliable manner.



### Kathy Draeger District 1 Board Nominee

### 1. Please tell Agralite Members a little bit about yourself.

My family includes husband Mike Jorgenson, and children Alma, Jens, and Lake. We live on the family farm in Malta Township, Big Stone County. Our three kids graduated from Clinton-Graceville-Beardsley school. Over the past years, we raised Lowline Angus beef, small grains, alfalfa/hay, and poultry. We were very proud to be named the Big Stone County Farm Family of the year in 2014 and also named Big Stone Conservation Farm of the Year in 2014. I work for U of M Extension as the statewide director of a program that works with communities throughout greater Minnesota.

#### 2. Why do you want to be a Director?

I believe in the Cooperative business model and would like to better serve the people in our area by serving on the Agralite board. Energy issues are an important issue of our time and will always be critical to the well-being of Agralite members.

### 3. What aspects of the director's job do you consider the most crucial?

Agralite Directors play an important role in bringing the concerns and needs of the co-op members to the board. Board members are tasked with serving as both an advisory and governing role for the member-based co-op. The energy world is changing rapidly with new technology changing how power is generated and distributed and even used! It is an exciting time to be a part of rural energy issues and I want to contribute to strategic decision making of how our coop will thrive going forward. The Agralite board has the serious responsibility to ensure its members have access to affordable and reliable electricity.

#### 4. What work experience or other board experience do you have that will help you be an effective Director?

I have been with U of M Extension for over 15 years and work with communities around the state of Minnesota. I have an entrepreneurial background having founded two successful S-Corporations focusing on agricultural and environmental research and development, one of which was sold to an engineering firm. Because of my business background, I continue to look for future opportunities for our coop and our members. I have served on multiple nonprofit, church, and other boards of directors and take my responsibilities seriously. We are members of Trinity Lutheran in Clinton, MN, and I served on the church council for 6 years. I helped start and served on the board of the Clinton-Graceville-Beardsley School Foundation that is associated with the Southwest Initiative Foundation. We are active members of Big Stone County Farmers Union and the Sustainable Farming Association and members of Farm Bureau.

### 5. What challenges do you see for Agralite Electric Cooperative in the future and how does the cooperative meet these challenges?

Agralite maintains 2,400 miles of power lines and is responsible for providing power to the 3,700 members of the co-op. There are changes occurring in the national conversation surrounding power generation and energy usage and Agralite is preparing for how those changes could impact members. Even more, Agralite has an opportunity to understand how those possible changes could be used to leverage benefits to members and mitigate market risk factors. While there may be some business opportunities in renewable energy (like the community solar garden that Agralite features in its newsletter), Agralite has the responsibility to make sure that affordable energy is available to all of the membership.

### **Training Stages for Electric Lineworkers**

Known for their strength and agility, lineworkers are dedicated to ensuring our communities have reliable power. Safety is always top priority on the job, which is why lineworkers spend thousands of hours training as they advance their skills.

Here's a look at the career progression of a lineworker.

### **Crew Leader**

A crew leader is an advanced position that requires supervising lineworkers on job sites, coordinating with contractors, and directing daily activities for crews.



### Journeyman Lineworker

Post-apprenticeship and with roughly 7,000+ hours of training under their belt, journeyman lineworkers are fully trained in their field. They repair, update, and install overhead and underground power lines, as well as other electrical equipment.



### Apprentice Lineworker

Before reaching lineworker status, they are required to work as an apprentice. Apprentice lineworkers earn competitive wages while recieving hands-on training and experience in the field. They typically spend four years in their apprenticeship.



### Apprentice Lineworker

Many lineworkers begin their career as a groundsperson, or linehelper. They assist line crews with tools, keeping job sites safe and operating smaller equipment.

Regardless of stage, all lineworkers continue education and training throughout their career. Training and testing requirements vary from utility to utility.

### 5 WAYS TO SAVE THIS SUMMER

When summer temperatures rise, so do our energy bills. Here are a few ways you can reduce energy use and grow your summer savings.

- Raise your thermostat.
  The smaller the difference
  between the indoor and
  outdoor temp, the more
  you'll save.
- 2. Install window coverings like blinds or light-blocking curtains to prevent indoor heat gain during the day.

- Seal leaks with caulk and weatherstripping around windows and exterior doors. Air leaks force your air conditioner to work harder and run longer than necessary.
- Run ceiling fans for additional cooling but turn them off when you leave the room.
- Lower your water heater thermostat to 120 degrees to reduce standby heat loss.

### MINUTES OF MEETING BOARD OF DIRECTORS March 2024

Board Chairman Warren Rau called a meeting of the Board of Directors of Agralite Electric Cooperative to order at 8:30 a.m., March 28, 2024. All members of the Board were present. The agenda, minutes of the last meeting, the monthly disbursements, the payment of capital credits of deceased members, Work Order #562, and February Special Equipment were approved.

Jonathan Messner, Manager of Member Services, reported on activities of his department for the month. He discussed load control for the month. He discussed the Briggs generator program, Distributed Energy Resource applications, and the ALM project. He discussed the two Power Hour events. He stated that the MNTwins Youth Baseball Clinic will be June 30th. He discussed a potential REDLG loan opportunity for a new butcher shop in Agralite's territory. He discussed the Agralite logo.

Stephanie Wrobleski, Manager of Finance/CFO, discussed margins for the month of February. She discussed patronage updates and a SmartHub promotion she is working on. She brought forth 2023 Capital Credit Allocations and the Board approved it.

Board Policies 200-215 were reviewed and the Board approved the recommended changes.
